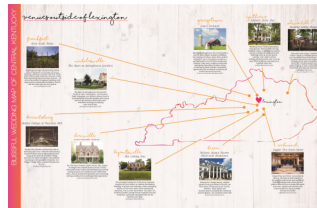

Cancellations and transfers of payment will not be accepted between magazine issue or any other Bridal Bliss entities. Each issue of publication is quoted and printed based upon contracted commitments.

Commissions

All rates quoted are gross.

Copy Acceptance

Bridal Bliss reserves the right to reject any advertisement regarded as objectionable in wording or appearance and may require the "Advertisement" in any ad submitted. Reference to any Bridal Bliss entity in advertisements, promotional material or merchandising by advertiser or agency is subject to prior written approval by Bridal Bliss. No allowance will be made for errors that do not materially affect the value of the advertisement. Bridal Bliss' liability for an error shall not exceed the cost of the space occupied by the error. Bridal Bliss' publishing liability for color errors shall not exceed the cost of the color price for the advertisement.

Copy Authorization

All advertisements are accepted and published upon representation that the party placing such material is authorized to publish any and all such material. In consideration of acceptance, the advertiser and/or agency agrees to indemnify and hold Bridal Bliss harmless from and against any loss of expense on claims based upon the subject matter of such advertisements.

Guaranteed Placement

To create convenience for our readers and advertisers, every attempt is made to place advertisements by nature of content. Requests for position can be made but are never guaranteed (with the exception of purchased premium positions). No adjustments will be given if and when a request is not fulfilled.

Advertising Design

Advertising layout is considered to be an integral element of the magazine's look. Advertisements get better results when they catch the reader's attention, and we've established design criteria with that goal in mind. Bridal Bliss will maintain the highest editorial standards for content. We will not publish explicit verbal or pictorial content.

Digital Specs

Digital advertising materials must be provided as PDF, Illustrator or Photoshop EPS files. PDF is the preferred format. All text must be converted into vector format and all pictures need to be embedded into the file. Only postscript fonts will be accepted. Text in vector EPS must be converted to outlines or paths to prevent font problems.

Due to dot gain and various registration issues with newsprint, please guard against the following: 1) The use of reversed type less than 9 point in size, especially on 4-color backgrounds. 2) The use of reversed type less than 9 point in size when in light, condensed or compressed typefaces. **Please flatten all transparencies. Any changes due to unflattened transparencies will not be the responsibility of Bridal Bliss. No adjustments will be made due to transparency errors.**

For print, all images must be saved as TIFF or EPS only. All images must be in CMYK mode only. Images saved as Lab color, duotone, indexed or RGB colors are not acceptable. PDF's with color images must be composite CMYK documents. All scanned halftone images should be sized at a resolution of at least 170 dpi (85 line screen) at 100% of the size used in the file. Line art should be at a resolution of at least 600 dpi at 100% the sized used in the file.
